	 <u>Proceed in Support</u> Service Connected Disability - Sections 88-79, 88-285, and 88-336 (Contributory, Noncontributory, and Hybrid). Deputy Attorney General Elmira Tsang submitted information and Deputy Attorney General Ivan Torigoe discussed the definition of "accident" and what constitutes an accident and recommended that the ERS submit legislation clarifying the statutes governing service- connected disability retirement.

- Accidental Death Sections 88-21, 88-286, and 88-239 (Contributory, Noncontributory, and Hybrid);

- Hawaii Domestic Relations Orders Section 88-93.5 (Distribution of Property in a Divorce Action Maximum Allowance); and
- Retain Unclaimed Member Benefits Sections 88-74.7, 88-96, and 88-341 (Commencement of Benefits, Rights of Members Separated from Service).

- Exempt and Additional Investment Staff Section 88-29 (Officers, Employees, and Legal Adviser;
- AFC Changes from "Highest 5" to "Last 5" Section 88-81 (Average Final Compensation);
- Change to Calculation of Unused Sick Leave Credit for Current Members Section 88-63 (Credit for Unused Sick Leave); and
- Change to the Calculation of Post-Retirement Benefits for Current Members Section 88-90 (Post Retirement).

The positions adopted by the Administrative and Legislative Committee on the bills presented will be recommended to the ERS Board for their approval at its next meeting in September.
