INVESTMENT MANAGER ORGANIZATIONAL CHANGES

Mr. Vijoy Chattery, ERS Chief Investment Officer (CIO), reported that there were no reported changes in organizational personnel or structure over the last period.

INVESTMENT MANAGER MEETINGS – 3<sup>RD</sup> QUARTER 2013 The CIO provided an overview of the investment meetings attended by Investment Office staff with investment managers currently under contract with the ERS and potential investment managers and other service providers in the third quarter of 2013.

CHIEF INVESTMENT OFFICER'S REPORT ON INVESTMENT OFFICE ACTIVITIES – OCTOBER 2013 The CIO reported on the activities of the Investment Office for October 2013. Highlights included:

- Introduction of Investment Specialists Andrew Chen and Ian Wetzel, who began work on October 1, 2013.
- A preliminary meeting with the executive search firm, Kumabe HR, was held to discuss the recruitment for the Investment Officer positions.
- The CIO met with BlackRock in San Francisco to discuss performance and allocation issues; formal report of due diligence site visit to be presented by the CIO at the November 2013 Board meeting.
- On-going monitoring of investment managers on the "Watch Status" list due to underperformance: CS McKee (Russell 1000 Value) and Mercator (MSCI World ex. US Net Dividend).
- The CIO and Mr. Wesley Machida, ERS Executive Director (Executive Director), attended the Omidyar Fellows Cohort II Program Kick-off Reception in Honolulu on October 6, 2013.
- The CIO is scheduled to speak at the Hawaii Kai Rotary Club on October 22, 2013.
- The CIO is scheduled to participate on a panel presentation with Mr. Hank Kim, Executive Director for the National Conference on Public Employee Retirement Systems (NCPERS).

INVESTMENT OFFICE MANAGER MEETING AND CONFERENCE SCHEDULE

GROWTH RISK CLASS GUIDELINES

Mr. Neil Rue of Pension Consulting Alliance, Inc. (PCA), ERS's investment consultant, presented for the Board's approval, the final draft of the amendments to the ERS's Investment Policy Statement for adoption of a "Risk Class Framework." The Growth Risk Class guidelines are incorporated in the ERS's strategic allocation and replace "asset allocation" with the concept of "strategic allocation."

On a motion made by Trustee Matsumoto, seconded by Trustee Barfield, and unanimously carried, the Board approved the amendments to the ERS's Investment Policy Statement as presented, to be effective April 1, 2014.

FIXED INCOME ASSET CLASS REVIEW

Mr. Rue presented PCA's review of the ERS's fixed income structure. PCA proposed a new concept for the ERS's fixed income investments that would further establish the ERS's risk class framework. The proposed concept seeks to: align different fixed income strategies with their appropriate risk classes; reduce interest rate risk; increase income; maintain high quality; and maintain/improve risk-adjusted return profile. Mr. Rue also presented PCA's a growth risk analysis of ERS's fixed income managers, and discussed with the Board the differences between capital allocation and risk allocation.

PRIVATE EQUITY POLICY

Mr. Paul Yett of Hamilton Lane reported on the status of Hamilton Lane's transition into the role of private equity consultant for the ERS. as well as on-going activity related to transition of the management of the private equity portfolio to Hamilton Lane from Abbott Capital Management, effective January 1, 2014. The CIO and Mr. Yett presented for the Board's approval, amendments to the ERS's Private Equity Portfolio Policies and Procedures.

On a motion made by Trustee Matsumoto, seconded by Trustee Barfield, and unanimously carried, the Board approved the amendments to the ERS's Private Equity Portfolio Policies and Procedures, subject to editing for form and style by PCA.
