This information included: (i) Partner's Capital Statements for NGGMSF with respect to three of the underlying funds in the portfolio, Neoma Africa Fund III, Templeton Turkey Fund (B) and Abraaj North Africa Fund II; (ii) information provided by the manager of Neoma Private Equity Fund IV with respect to NGGMSF's capital account balance and its interest in the fund; and (iii) estimates for the expected sale price of Hamilton Lane's interests in the Infrastructure Growth and Capital Fund ("IGCF") based primarily on information provided by the general partner of IGCF.

In addition, the general partner of NGGMSF provided us with information regarding other balance sheet items for NGGMSF. Hamilton Lane cannot provide any assurances as to the accuracy of this information, and note in particular: (i) audited financial statements have not been issued for NGGMSF or one of the five funds held by NGGMSF since 2017; (ii) Hamilton Lane utilized the negotiated sales price for certain positions and there is no guarantee the transaction will close. (iii) at least two of the funds held by NGGMSF have suffered losses due to the fraudulent activities of the prior manager, and while the valuation reflects some of such losses, the full extent of the harm from such fraudulent activities may not yet have been identified; and (iv) the prior manager of NGGMSF and its holding company are in liquidation proceedings and there is a risk that the liquidators or other third parties could claim that payments made to NGGMSF or funds held by NGGMSF were fraudulent and must be returned and there is active early-stage litigation to this effect against one of the funds held by NGGMSF.
