- **Market Benchmark:** 70% Broad Growth Historical Benchmark and 30% Diversifying Strategies Benchmark since 01/2024.
- **Broad Growth Historical Benchmark:** 56% Global Equity Historical Benchmark, 17% Global Credit Historical Benchmark, and 27% Real Assets Historical Benchmark since 01/2024.
- **Global Equity Historical Benchmark:** 51.3% MSCI All Country World IMI (Net) and 48.7% MSCI All Country World IMI (Net) (quarter lagged) since 01/2024.
- **Global Credit Historical Benchmark:** 33.3% Public Credit Benchmark and 66.7% Private Credit Benchmark since 01/2024. **Public Credit Benchmark:** 50% Bloomberg Global High Yield (Hedged), and 50% Morningstar LSTA US Leveraged Loan 100 since 07/2021. **Private Credit Benchmark:** 50% Bloomberg Global High Yield (Hedged) (quarter lagged) and 50% Morningstar LSTA US Leveraged Loan 100 (quarter lagged) since 01/2024.
- **Real Assets Historical Benchmark:** 47% FTSE EPRA NAREIT Global REITs Index (Gross) (quarter lagged), 7% S&P GCSI Agriculture Index (quarter lagged), 9% S&P Global Timber & Forestry Index (Net) (quarter lagged), 37% Dow Jones Brookfield Global Infrastructure Index (Net) (quarter lagged) since 01/2024. This benchmark was inceptioned in 10/2014; it does not have a return for "Since Inception" column which presents the returns since the composite accounts' inception.
- **Diversifying Strategies Historical Benchmark:** 86.7% Liquid Defensive Historical Benchmark and 13.3% Illiquid Diversifying Historical Benchmark since 01/2024.
- **Liquid Defensive Historical Benchmark:** 31% Mount Lucas Global EV (15V), 15% Bloomberg US Treasury: Long, and 54% Bloomberg US Treasury: Intermediate since 01/2024.
- **Illiquid Diversifying Historical Benchmark:** 100% Swiss RE Global Catastrophe Bond Hedged Index since 01/2024.
